#### **Scholarship Guide**

#### **Master the Basics**

#### Where to start

- Go online and take advantage of free scholarship matching services such as <a href="www.fastweb.com">www.fastweb.com</a> for local, regional, state, national awards and college-specific scholarships.
- Ask your school guidance counselor about local, private and corporate sponsorships.
- Search your community. There are many philanthropic and non-profit organizations that may offer awards. Visit your school or local public library to research scholarships. Ask your parents' employers and unions if they sponsor scholarships for children of employees.

#### How to prepare

- Get organized and keep the scholarships you are working on separate from those you have not started. Use a calendar to keep track of dates and deadlines or the status tool available on <u>Fastweb</u>.
- Know your time frame to apply. Complete and submit the easiest scholarships first. Then focus on the scholarships with earlier deadlines and ones that may require more time. Allow plenty of time when requesting letters of recommendation.

#### Submit your application

- Remember to check your spelling and grammar.
- Proofread your materials and have a teacher, parent or friend review your application and essay if submitting online or by mail. They can provide feedback and catch mistakes.
- Keep a copy of your application, if you submitted paper or electronic copy.

#### The Scholarship Essay/Application

#### Before you begin:

 Develop a theme that fits the scholarship. Learn about the scholarship provider's mission and goals. Tailor your essay/application to complement the sponsor's expectations. For example, if the provider is interested in community service, highlight ways you impact your campus community and your community at large within your essay. Here are a few topic ideas:

#### Personal achievements

- Talk about specific interactions you had with others.
   Sponsors want to know the impact you had on others and what this says about "you". Do you still keep in touch with anyone you've helped? How did you influence their lives?
- How did your achievements reflect your values? Why are your achievements important to you? Did you do something that received high praise or recognition?
- Personalize your experience. For example, what makes the volunteer and community service you've performed unique? What made you stand out?

#### Academic plans and possible major

- Instead of saying, "Science is my favorite subject," discuss a specific assignment or project that you worked on that sparked your interest. Give examples.
- Avoid saying that you selected a major or career path to "help people." What specific actions can you take to improve the lives of others? Discuss how your values are relevant to what you will be studying in college.

#### Social issues and current events

- Think about current issues or events in the news that you feel strongly about.
- Do you know a lot about a controversial topic?
- Do you know of someone who is directly involved in an issue who might be able to provide insight?

#### Mentors, admirers and influences

- Think about your friends and family, community and the things you've learned outside of the classroom. Pick specific people, incidents and learning experiences to write about that will let your personality come through.
- Is there a person you aspire to be like within your chosen academic major or career path? Someone who encouraged you to succeed?
- Focus on specific qualities or actions that the person has inspired in you.

#### What Do Judges or Evaluators Look For?

**Do you qualify?** Every year, students waste time by applying for awards they aren't eligible to win. If you don't meet the eligibility criteria, don't enter!

**Is your application presented well?** Type your essay and check for grammar and spelling errors. Place the application, essay and other contents in a large folder for mailing. Do not fold any of the materials.

Did you include all required documents? Make sure you include all required academic transcripts, references and letters of recommendation. When selecting individuals to provide you a letter of recommendation, be sure you know them very well and give them ample time to provide you a letter and provide them a self addressed stamped envelope, if it will be mailed.

**Did you answer all of the questions?** Double-check that you haven't forgotten any required information.

### **Scholarship Scams Tip Sheet**

#### How do I recognize a scholarship scammer?

- Indicates you won an award for which you didn't apply
- Does not supply valid contact information
- · Guarantees you will win an award
- Requires personal financial information (such as, credit card numbers, checking account numbers, and/or Social Security numbers to verify or hold a scholarship)

#### How do I recognize a legitimate scholarship services?

- · Does not guarantee you will win an award
- Sends information about awards when you request it
- Makes contact information available upon request
- Should not direct you to a fee-based provider because they know that financial aid information is readily available for free

#### What if you suspect a scam?

- Save all of the forms you receive from the company
- Keep copies of written details about the offer and any correspondence, emails or other paperwork
- · Make sure all materials are dated
- Take notes during seminars and phone conversations (record the date, time, phone number and the person's name with whom you spoke), include a detailed account of your conversation
- Take a copy of all literature and correspondence concerning the scholarship to your school's financial aid office, who can verify if the organization is legitimate.

#### **Financial Aid Seminars & Consultants**

How do I protect myself from being scammed by a consultant or financial aid seminar?

- When choosing to utilize the services of a consultant, consider their qualifications carefully. Find someone who has worked as a college financial aid administrator, Certified Public Accountant (CPA) or Certified Financial Planner (CFP).
- If a financial aid consultant refuses to sign the paid preparer section of the FAFSA that is a red flag.
- Some seminars use high pressure tactics to get you signed up for their service, while only answering questions after you agree to pay a fee. Don't trust anyone who encourages you to do something unethical. If you falsify financial aid forms, you can be fined \$20,000, sent to prison, or both. If you need help understanding the financial aid process, contact your financial aid office as soon as possible.

#### **Beware of False Claims**

"For a small fee, we'll give you a list of scholarships."

- Never spend money on a fee-based matching service. The biggest and best award databases are free online. "We'll help you complete complicated forms."
- Information about the Free Application for Federal Student Aid (FAFSA) and other forms is available for free from your guidance counselor, your library and the U.S. Department of Education. You still have to fill out the same basic information for a fee-based service that you would directly for the FAFSA.
- Your school financial aid administrator and College Goal Sunday programs can help: www.collegegoalsundayusa.org.
- For general financial aid or FAFSA-related questions, call 800-4-FED-AID (800-433-3243).

"You are guaranteed a minimum of \$1000 in awards."

 A service can't guarantee any scholarships because they have no control over the scholarship judges' decisions.

"We have a 96% success rate."

 These false success rates indicate the percentage of students they've successfully matched with the database, NOT the number of students who actually receive money.

"We'll need a bank account and pin or credit card number to verify your information."

 A legitimate scholarship provider won't ask for bank account, credit card or Social Security information.

"We will do all the work for you."

 To win a legitimate scholarship, you must submit your own applications, write your own essays and solicit your own letters of recommendation.

## **Key Scholarship Application Information Quick Reference Guide**

#### Tips for Applying for and Managing the Scholarship Search

- Start searching for scholarships as soon as possible. There are many scholarships available to students in grades K-11, so don't wait until spring of your senior year. Continue searching for scholarships even after you are enrolled.
- Use a free scholarship matching such as Fastweb.com. The Fastweb database is updated daily and the site will email notifications of new scholarships that match your profile.
- Answer all of the optional questions on a scholarship matching web site to create as many matches as available.
- Look for local scholarships on bulletin boards near the guidance counselor or financial aid offices, or the library's jobs and careers section. Improve grades for more matches.
- To win more scholarships, apply to every scholarship for which you are eligible. It gets easier after several applications. Also, pursue small awards and essay contests. Essays can be reused and tailored to each new application.
- Don't miss deadlines. Use checklists to get organized.
- Tailor your application to the sponsor's goals. Read and follow the instructions carefully.
- If you have difficulty writing essays, record yourself as you
  answer the question out loud and transcribe the recording. Most
  people think and speak faster than they can write or type. Write
  an outline afterward to organize your thoughts.
- Personalize your essay and be passionate. Write about something of interest to you. Make your application stand out from the crowd, talk about your impact on other people and give specific examples.
- Check your online presence to ensure that it looks professional.
  Review your social media profiles and remove inappropriate and immature material. Use a simple email address, such as firstname.lastname@gmail.com.
- Proofread a printed copy of your essay and the application for spelling and grammar errors.
- Make a copy of your application before mailing it. Send by certified mail, return receipt or with delivery confirmation.

#### **Common Scholarship Application Mistakes**

- · Missing deadlines
- Failing to proofread the application
- Failing to follow directions, especially regarding essay length and the number of recommendations
- Omitting required information
- Applying for an award when you don't qualify
- · Failing to apply for an award for which you are eligible
- Failing to tailor the application to the sponsor
- Writing a boring essay
- Writing an essay that may offend the reviewer
- Including exaggerations or lies on your application

#### **Beware of Scholarship Scams**

- If you have to pay money to get money, it's probably a scam.
- Never invest more than a postage stamp to get information about scholarships or to apply for a scholarship.
- Nobody can guarantee that you'll win a scholarship.
- Do not give out personal information like bank account, credit card or Social Security numbers.
- Beware of the unclaimed aid myth. The only money that goes unclaimed is money that can't be claimed

## Writing Your Personal Statement: Telling Your Story

The personal statement is the opportunity to make yourself stand out from other applicants. Make sure your essay tells readers something they would not have otherwise found out in your application.

Usually instructions are very general, such as "Tell us a little bit about yourself," or "What is important for us to know about you?" The broadness of this topic can be overwhelming. Here are some questions to help you brainstorm some ideas:

- What is special, unique, and/or impressive about you or your life stories?
- Have you ever had to overcome unusual obstacles or hardships (economical, familial, physical)? What have you learned from these challenges?
- What details of your life will help the reader better understand you and set you apart from others? You might include personal challenges, personal history, people or events that have shaped and influenced you and your life goals.
- How are you the best fit for the scholarship? What have you done to prove that you are worth this scholarship's funding?
- What are your personal, academic, and professional goals? What has led you to pursue these goals?
- How have you contributed to the community (extracurricular activities, community involvement, family responsibilities, employment)? What have you learned from these experiences?
- Are there any gaps or discrepancies in your academic record that you should explain?
- Why might you be a stronger candidate or more successful in your chosen profession or field than other applicants?
- What are the most compelling reasons you can give to the scholarship committee to be interested in you?
- How do you plan to give back to your community once you finish your education?

Note: Follow the directions carefully and adhere to word and page limits, formatting requirements and subject guidelines. Please keep in mind that selection committees will be reading multiple applications, and you do not want to be penalized because you went over the page limit. That being said, make sure to use all the available space they give you. a little bit of body text

## **Writing Tips**

- Tell a story. Show or demonstrate an experience through concrete examples. If your statement is fresh, lively and different, the selection committee will remember you and put you on the top of the pile.
- The most memorable paragraph is the opening one, so focus on that one. The opening paragraph is where you can grab the reader's attention. Or you can make the reader yawn and say "What's this applicant's name again?"

  Distinguish yourself from other applicants right away.
- Topic-Specific Essay Tips: Some scholarships might ask you to write an essay, rather than a personal statement. Make sure that your essay directly addresses the topic and that you aren't simply pasting on a new topic sentence to an old essay. By all means, use sections of your personal statement, but don't just copy and paste it.

# How to Get a Winning Letter of Recommendation

Identify and speak to potential recommenders EARLY in the process. DO NOT WAIT UNTIL THE LAST MINUTE. Notes on Timing:

- Arrange talks with potential recommenders
- Decide on best recommenders for you
- Ask for a letter of recommendation (ideally 2 months before due date)
- Give recommendation forms (at least 1 month before)
- Politely remind recommenders about the letter (at least one week before due date)
- Thank recommenders
- Update them on the scholarship selection process if you have been selected for an interview, if you have been awarded the scholarship, etc.
- Teachers are very busy. Make their jobs as easy as possible. Give them a copy of your personal statement (even if it's just a draft), a list of your accomplishments/achievements/awards/extra-curriculars. Let them know what you'd like them to highlight/emphasize about you. This is not being overbearing; this is being helpful.

# How to Get a Winning Letter of Recommendation

- Make information clear to recommenders. Pull together all scholarship info (scholarship name, your full name, due date, address to be mailed). Add information about the scholarship and its requirements and priorities.
- Make sure they are addressing recommendations correctly. Don't use a recommendation written for a different scholarship without changing the name of the scholarship throughout!
- Make sure your recommender is knowledgeable about you and can speak highly of your academic accomplishments, strengths, interests, academic and professional goals. Have an open talk with recommenders about your need for money and your immigration status.
- This is especially important if you are not comfortable talking about your status, since your recommenders can do so for you. It is important for them to fully understand your situation so they can advocate for you effectively. If you think your recommender is not supportive of you because of your immigration status, find a new one.
- Don't be afraid to ask recommenders to submit recommendations for multiple scholarships. Once they've written on recommendation, it's easy for them to modify it.

# How to Get a Winning Letter of Recommendation



- Update them on your progress (whether or not you've been awarded scholarships).
- Ask recommenders if they will share a copy of their recommendation with you. If so, ask them for a "generic" recommendation (not addressed to any particular scholarship fund) that you can have on file and use if necessary.
- I'm a college student. Is it okay for me to ask my high school teacher to recommend me? Ideally you should have a current instructor write you a recommendation, but it is better to have a former teacher who knows you well rather than someone who doesn't know you very well.

If you are going to ask a former teacher, make sure to talk to that teacher about your current activities and progress in school, so they can update their old recommendation letter.

• Stay in touch with your former mentors and teachers!

# Different Ways for Recommenders to Talk about Your Immigration Status

#### Least Direct

Yoshi works harder than any student I have ever taught. She is more determined than any student I have ever taught. Her heart is filled with positive energy. Her mind races to accumulate and assimilate new information. And she facesheart-braking obstacles—poverty, immigration status, financial independence since was sixteen, an utter lack of local family support and an almost untenable living situation with a generally uninterested aunt. She works so hard for herself because she feels she has no choice but to continually learn and grow so that one day she may be of great service to others. As difficult as her path has been and will continue to be, it is her goal to ease the path for those who come after her.

#### More Direct

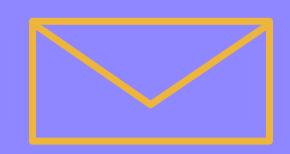
Julio is a first generation college student. He is asecond year student majoring in Civil Engineering at San Jose State University...Julio is considered a minority at San Jose State University because of his ethnic background and low-income status, yet he has been able to compete and excel with students who have no economic needs or better educational resources than him before starting their college career....Unlike most San Jose State University students who do not need to worry about finances, Julio has to. He faces financial struggles on an ongoing basis due to his legal status which does not grant him any source of government financial aid.

#### Very Direct

Luis is a non-native English speaker and an undocumented immigrant who will also be the first in his family to graduate from high school and attend a four-year college. And he will graduate—that's the type of person Luis is. Luis turned his back on the drugs and violence in his community to face the challenges of preparing for a post-secondary education. More aware and introspective than most young adults, Luis has realized that competing with more privileged students at the college level requires him to compensate for the inequities of life in East Palo Alto by preparing better and working harder.

## Before Mailing: Do a Final Check!

- 1. Is your application filled out completely? Have you signed your application?
- 2. Do you have all required documents, including transcripts and proof of income?
- 3. Have you proofread and edited your essays? Did you follow the essay guidelines?
- 4. Re-read the whole package
- 5. Send it in before deadline WAY BEFORE THE DEADLINE



## **Scholarship Interviews**

#### Getting ready for the Interview:

- Make sure you know the interview time and location, and how to get there
- Do a mock interview with a teacher, counselor, or mentor
- Dress nicely
- Learn about the scholarship (background of funders, key people involved, activities required of recipients)
- Have questions ready to ask interviewers (you can ask them about one of the organization's programs that you might be interested in or other specific questions about the organization)
- Think of three things you definitely want to tell your interviewers (make sure you talk about these three things)
- Prepare your resume, bring it to the interview (in case they want to look at it)
  and read through it so you remember what your experiences/responsibilities
  were
- If you can, prepare a budget with your academic and personal expenses, committed/pending funds, and unmet need and bring copies of it to the interview

# **Scholarship Interviews**

#### During the interview:

- Be early (know the location ahead of time)
- Shake hands with every person
- Say thank you (at LEAST once)
- Look them in the eyes
- Be prepared to ASK questions if it is appropriate and if you are invited to do so
- Sample Questions that Might be Asked During the Interview
- Why did you apply to this scholarship?
- What makes you stand out from all other candidates?
- How will you be able to contribute to our community?
- Tell us about one event or person in your life that has shaped you.
- Talk about your academic achievements/aspirations.
- Talk about your community involvement.

#### After the interview:


• Send a thank-you note -- preferably by mail, but email is better than no thank-you note at all.

## **Best Practices - Pt. 1**

Find as many scholarships as possible



Find as many scholarships as possible (especially local ones) that do not require citizenship. Local scholarships are less competitive because they limit the pool of applicants.

Make sure to research and apply to scholarships EARLY!

Make sure to research and apply to scholarships EARLY – ideally starting in the spring ofjunior year in high school. Many scholarships are exclusively available to high school seniors and not for college students, so make sure to start building a college fund with these high school-specific scholarships.

Note: If you have good grades in high school, you should take advantage of them and apply to scholarships that are focused on academics. In general, when going on to college, even stellar students' GPAs drop dramatically, which affects their level of competitiveness.

Apply to every single scholarship you can.

Scholarships are very competitive, especially ones that award large amounts of money. Focus on throwing your net wide and applying to as many scholarships as you can. Plus, once you have created a solid personal statement and gathered all the documents that scholarship applications require, you will be able to use the same materials over and over.

## **Best Practices - Pt. 2**

Be very explicit in talking about your story.

The personal statement is what will set you apart from all other applicants. Don't hesitate to talk about your immigration status. Tips for how to share your story can be found in the "Writing Your Personal Statement" section.

Answer questions clearly and directly

Type and proofread essays. Spelling mistakes and bad grammar turn readers off. Express yourself clearly and concisely. Adhere to the word and page limits. Have at least two people look over your personal statements. More than three people will give you too many opinions to juggle. If English is not your first language, ask for your English teacher's help.

State your financial needs

Don't be shy about it. Even scholarships that are not need-based should know your financial needs. If you are high-need and high-merit, you have been able to persevere despite numerous challenges and should highlight this in your essay.

Here's how you might talk about your situation: Are you expecting family assistance to pay for college? What would happen if you did not get this scholarship? How would your financial limitations impact your academics and/or your chance to finish your education?

# **Best Practices - Pt. 3**

Research the particular organization

Research the particular organization offering the scholarship to understand what they are looking for in applicants. If you clearly articulate why you're a good fit for a particular organization, you help the selection committee in choosing you as the right candidate. Make sure to use concrete examples when you write about your strengths, but never write in an arrogant manner. Don't act like you know what's best for the scholarship organization.

Put A LOT of time and energy into scholarship applications.

Revise your personal statement multiple times, get feedback about your essays from multiple people, gather transcripts, income statements, etc. The more effort you put in, the better your scholarship packet will be and the higher the likelihood of winning the award.

• It's all about the package.

As soon as you're about to finish the scholarship application, read over all the application materials to see if they reflect who you are as a whole. Materials should complement one another. Do a final checklist to ensure that you have enclosed all necessary documents needed. Make sure your scholarship application is signed.

#### **SCHOLARSHIPS**

Think of applying for a scholarship as having a parttime job. Let's say you spend 20 hours searching and putting together applications and you receive a \$1,000 scholarship—that's like making \$50 an hour!

#### Where to find them?

- Your school will have a list of scholarships offered by your local community organizations, such as Rotary International, 4-H and others, as well as those provided by neighborhood banks and businesses.
- Ask your teachers, counselors or coaches—and look at magazines or on Web sites devoted to your interests or skills.
- Your parents' work or labor union may offer scholarships for the children of employees.

- Use the free Internet search engines, such as www. google.com, www.dogpile.com, www.yahoo.com and www.ask.com.

#### Free scholarship or a scam?

A scholarship or grant is *free* money—you should never have to pay to find, apply for or receive one. Here are some tips:

- Do your own research before spending your money.
   Most scholarship information is available for free
- Don't fall for claims that "guarantee" a scholarship. Any claim should include qualifications or disclaimers.
- Never give your credit card information, bank account information, Social Security number or student identification number over the telephone or Internet unless you made the call and know who you're talking to. And never provide any personal or financial information to hold a scholarship or grant.

#### **Make Your Scholarship Application Stand Out**

Be sure you submit everything that is required to apply for the scholarship and to meet the deadline. Send originals whenever you can or clean photocopies. Consider binding materials in a brightly colored report folder to keep everything together. Also, send your materials flat, not folded, in a large envelope.

#### WHAT ARE THE BENEFITS?

Waiver of all mandatory system wide tuition and fees at any State of California Community College, Campus of the University of California, or Campus of the California State University system.

#### WHO MAY APPLY?

- ${f 1}$  Students must meet the California residency requirements as determined by the college they will attend. AND
- 2 Students who meet the requirements of at least one of the following plans:

**PLAN A:** The spouse, unmarried child, or unmarried surviving spouse of a veteran who is totally service-connected disabled (rating

must have occurred prior to the child's 21st birthday) or who has died of service-related causes, may qualify. The veteran must have served during a period of war declared by Congress, or been awarded a Campaign or Expeditionary Medal. This program does not have an income limit. A child must be under 27 years of age to receive the fee waiver benefit. The age limit is extended to 30 years of age if the child is a veteran. There are no age limits for a spouse, unmarried surviving

spouse. \*NOTE: A dependent cannot receive this benefit if they are in receipt of VA Chapter 35 benefits.

OR,

**PLAN B:** The *child* (no age limit) of a veteran who has a service-connected disability, or had a service-connected disability at the time of

death, or who died of service-related causes, may also qualify for a waiver. The child's income, which includes the student's **ADJUSTED GROSS INCOME**, **PLUS THE VALUE OF ANY SUPPORT** received from a parent, cannot exceed the "national poverty level" as published by the U.S. Census Bureau on December 31<sup>st</sup> of last year. \*NOTE: This figure changes annually. To obtain the applicable national poverty level, contact your local County Veterans Service Office (CVSO). In cases where the DVS 40 reports \$0 AGI & \$0 Value of Support, a certified statement must be completed

which explains how the student affords to attend college and supports themself.

PLAN C: Any dependent or unmarried surviving spouse of a member of the California National Guard who was killed,

permanently disabled or died of this disability that resulted from activation under Military and Veterans Code Section 146.

**PLAN D:** Available to Medal of Honor (also known as Congressional Medal of Honor) recipients and their children.

#### **HOW TO APPLY:**

(1) This form must be fully completed and signed by the student and the veteran. If a question does not apply, write "N/A". If veteran is unable to sign, parent/ must complete and attach a VSD-021.

- (2) A child, under PLAN B, must submit either a student-**SIGNED** copy of their federal income tax form 1040 or state income tax form 540, from "Last Year" or, if a child does not have a copy of their income tax, or if a child did not file a return, they must submit a *statement* from the Internal Revenue Service (800-829-1040) or the Franchise Tax Board (800-852-5711) which **must verify the amount of Adjusted Gross Income** or the fact that a return was not filed. \*\*NOTE\*\*: Current academic year entitlement is based upon last year's adjusted gross income and value of support. For example: If applying for benefits for academic year 2017-2018, the total amount of your reported adjusted gross income and value of support from calendar year 2016 will be used to determine eligibility.
- (3) If you are a child of a veteran, <u>you must attach a Verification of Dependency.</u> Acceptable verifications include, but are not limited to, government-issued birth certificates, adoption records, and marriage certificates. Those seeking status as an Adopted Child or as a Stepchild must have entered into such status prior to the child's 23<sup>rd</sup> birthday.

#### WHEN TO APPLY:

Always try to apply for these benefits prior to attending school. Benefits are awarded on an academic year basis and students are required to reapply each year for ongoing benefits. **NOTE**: The earliest effective date fee waiver benefits may be awarded is the first day of the academic year in which an application is received.

#### WHERE TO APPLY:

To obtain an application, additional information and to apply for benefits under this program, contact your local County Veterans Service Office at: www.cacvso.org.

If eligibility criteria are met, use of the CalVet College Fee Waiver for Veterans Dependents may be applied to state-supported programs in the CCC, CSU, and UC systems. Some academic programs at these institutions that are considered self-supported, commonly referred to as extension courses or extended education are not covered under the CalVet College Fee Waiver program because these courses, degrees, and certificates are neither funded by the state nor are they system-wide programs. Veteran dependents applying for this waiver should research residency requirements and specific academic programs thoroughly before applying to the college or university.

# California Veteran Reintegration Program Fact Sheet Education

As a veteran there are several educational programs available which you may use for a wide variety of VA-approved education and training programs.

The California Department of Veterans Affairs (CalVet) and the California Community Colleges Chancellor's Office (CCCCO) have partnered together to assist service members, veterans, and family members by streamlining their application to a California Community College.

If you're not qualified for any VA education benefits, don't let that discourage you from enrolling in college. <a href="icanaffordcollege.com">icanaffordcollege.com</a> is a great tool to assist you in finding a way to further your education. Financial aid is available to cover enrollment fees and help with other costs such as books, supplies and even rent. Financial aid experts are located on all 112 campuses and are available to provide free one-on-one assistance.

You can also find contact information on the California Community College <u>financial aid offices</u> nearest to you. Depending on where you live, you might have received information for one office or for several.

The information includes the name of the college, its physical address (in case you want visit them in person), its web site address, a direct telephone number for the financial aid office, as well as an email address that you can use if you want to ask your questions online.

<u>CCCApply.org</u> is your online gateway to the California Community Colleges. Each year nearly three million students from all over the world build their career skills, prepare for transfer to four-year colleges and universities, or simply enrich their lives through learning at one of the 112 Community Colleges in California.

#### **NON-RESIDENT COLLEGE FEE WAIVER**

The Non-Resident College Fee Waiver waives non-resident fees at all State of California Community Colleges, California State University, or University of California campuses.

#### Who is Eligible?

 A student who is a veteran of the U.S. Armed Forces stationed in this state on active duty for more than one year immediately prior to being discharged is entitled to HONORING CALIFORNIA'S VETERANS resident classification. This classification is valid for the length of time the veteran lives in this state after being discharged up to the minimum time necessary to become a resident.

- An undergraduate student who is a member of the U.S. Armed Forces stationed in this state on active duty is eligible, except a member of the armed forces assigned for educational purposes to a state-supported institution of higher education.
- An undergraduate student who is a natural or adopted child, stepchild, or spouse who
  is a dependent of a member of the armed forces stationed in this state on active duty is
  eligible.
- A student seeking a graduate degree, who is a member of the U.S. Armed Forces stationed in this state on active duty except a member of the armed forces assigned for educational purposes to a state-supported institution of higher education, is eligible. There is a two-year limit for graduate-level studies.
- A student seeking a graduate degree who is a natural or adopted child, stepchild, or spouse who is a dependent of a member of the U.S. Armed Forces stationed in this state on active duty is eligible. There is a one-year limit for graduate level studies.

To apply, contact the Admissions Office of any State of California Community College, California State University, or University of California campus or the local County Veterans Service Office.

#### **TROOPS TO COLLEGE**

Troops to College, was created to attract more veterans to California public universities and colleges by making campuses more veteran friendly. The initiative was designed to showcase the full range of curriculums and services available to veterans at California state universities.

The program is designed to help veterans, especially combat veterans, transition to civilian life and the college environment. Veterans and their families may enroll in a course about combat stress, post-traumatic stress disorders, and other issues affecting veterans returning to civilian life. The course is taught by a VA counselor who is also a combat veteran. The curriculum is specifically designed to increase the student veteran's academic, work, and social success. The class provides participants instruction in interpersonal skills, methods of adapting to civilian life and work careers, and techniques for managing military operational stress.

#### CALIFORNIA NATIONAL GUARD EDUCATION ASSISTANCE AWARD PROGRAM (CNGEAAP)

The California National Guard Education Assistance Award Program (CNG EAAP) issues financial awards to qualifying members of the California National Guard (CNG) and State Military Reserve (SMR). This financial education benefit can pay for up to 100% of fees at the Universities of California, California State Universities, and California Community Colleges. It can also be used for eligible California proprietary and public institutions. With combined military training and a civilian education in areas such as engineering, nursing, communications and information technology, California's National Guard members will be able to serve on two fronts.

- Complete the Free Application for Federal Student Aid (FAFSA) found at www.fafsa.ed.gov.
- Complete the CNGEAAP application found at https://nationalguard.csac.ca.gov/Disclaimer.aspx.
- Download and print the Statement of Understanding found at <u>www.calguard.ca.gov/education</u> and have it signed by the veteran's Commander.

Note: Discretionary summers will not be covered by the CNGEAAP. Only participants attending mandatory summers will be eligible for an award check.

#### **U.S. DEPARTMENT OF VETERANS AFFAIRS EDUCATION BENEFITS**

#### **EDUCATION BENEFITS AND PROGRAMS FOR VETERANS**

There are several education programs veterans can use for a wide variety of VA-approved education and training programs, including: apprenticeship and on-the-job training, college degree and certificate programs, flight training, and correspondence courses. Each program provides different benefits to different groups of individuals and offers a specified number of benefits "months".

Typically, most education benefits can be collected for 36 months; however, the maximum that can be collected under any combination of VA education program is 48 months. Please note that veterans can only use one VA education benefit for training at a time. Please note that the following list of education programs is not all inclusive and that each individual's situation is different. It is important to pay careful attention when choosing an education program. If a veteran gives up one education benefit in favor of another, it is an irrevocable choice. Veterans are encouraged to check with the school's certifying official to determine which benefit best meets their educational goals.

#### POST-9/11 GI BILL

The Post-9/11 Veterans Educational Assistance Act of 2008 also known as Chapter 33, boasts the most comprehensive education benefits package since the original GI Bill was signed into law in 1944 by providing financial support for education and housing to eligible individuals.

A veteran may be eligible if they have at least 90 days of aggregate service on or after September 11, 2001 or were discharged with a service-connected disability after 30 days. Veterans must also have received an honorable discharge or have been medically discharged to be eligible.

Based upon the length of aggregate active service, veterans are eligible for a percentage of tuition and housing benefits under Chapter 33 that range from 40% to 100%. The following depicts the percentage of benefit ranges:

- **100% of benefit** 36 months of active duty service, or have been discharged for a service-connected disability after 30 days of continuous service
- 90% of benefit 30 total months of active service
- 80% of benefit 24 total months of active service
- 70% of benefit 18 total months of active service
- 60% of benefit 12 total months of active service
- 50% of benefit 6 total months of active service
- 40% of benefit 90 or more days of active service

Note: Qualifying service time excludes service on active duty in entry level and skill training; however, active service performed by National Guardsmen under Title 32 USC for the purpose of organizing, administering, recruiting, instructing, or training the National Guard or under section 502(f) for the purpose of responding to a national emergency now counts towards eligibility.

#### What Benefits do Students Receive under the Post-9/11 GI Bill?

This new education benefit goes well beyond only helping to pay for tuition. Depending on each individual's "rate of pursuit" (full- or part-time study) and situation, veterans may qualify for:

• **Tuition and Fees:** These payments are issued directly to the school on behalf of the individual at the time the certificate of enrollment is processed.

On Active Duty: Individuals on active duty may be allotted the total amount of tuition and fees for all public schools. The amount is not limited to the state maximum; however, effective August 1, 2011, private and foreign school costs are capped at \$17,500 annually. Effective October 1, 2011, students on active duty may receive a books-and-supplies stipend.

**Not On Active Duty**: The amount allotted is prorated according to length of service. The amount is limited to the highest amount of tuition and fees charged for full-time, undergraduate training at a public institution of higher learning in the state in which the student is enrolled. Effective August 1, 2011, private and foreign school costs are capped at \$17,500 annually. The Yellow Ribbon Program still exists for out-of-state fees and costs above the cap.

• Monthly Housing Allowance: This payment is issued directly to the student at the beginning of each month for education and training pursued the previous month. The amount is prorated based upon rate of pursuit, rounded to the nearest multiple of 10. If a student is training at a rate of pursuit of 75%, he/she would receive 80% of the Basic Allowance for Housing (BAH) rate. In prior years, students enrolled exclusively in online training were not eligible for the housing allowance; however, it is now payable to students (other than those on active duty). The housing allowance payable is equal to ½ the national average BAH for an E-5 with dependents. In 2013, the payable rate for a full-time student online was \$684.00. Effective August 1, 2011, break or interval pay is no longer payable under any VA education benefit program unless under an Executive Order of the President or due to an emergency, such as a natural disaster or strike. That

means that if the semester ends December 15th, the housing allowance is paid for the first 15 days of December only. If the next semester begins January 10th, payment will be made for the remaining days of January.

Note: Students using other VA education programs are included in this change. Monthly benefits will be pro-rated in the same manner.

- Books and Supplies Stipend: This payment is issued directly to the student when the school certifies and VA processes the enrollment. This benefit is prorated based on length of service. The books and supplies stipend can also be paid to students attending school while on active duty.
- Yellow Ribbon Payments: This program allows degree-granting institutions to enter into a voluntary agreement with VA to fund tuition expenses that exceed the highest public in-state undergraduate tuition rate for individuals eligible for the 100% payment tier. The institution can contribute up to 50% of those expenses and VA will match the same amount as the institution. This payment is issued to the school when the school certifies and VA processes the student's enrollment.
- **College Fund or "Kicker"**: These payments are issued directly to the student based on "rate of pursuit" and the education benefits program under which the kicker is payable. These payments are now made on a monthly basis. In the past they were made through a lump sum.
- Rural Benefit Payments: This one-time, lump-sum payment of \$500 is issued directly to a student who resides in a county with six persons or fewer per square mile (as determined by the most recent decennial census), and who either:
  - o physically relocates at least 500 miles to attend an educational institution, or
  - o travels by air (any distance) to physically attend an educational institution, if no other land-based transportation exists.

#### What Kind of Education and Training Does the Post-9/11 GI Bill Cover?

- **Graduate and Undergraduate Degrees**: Courses must be offered by a degree-granting institution of higher learning and approved for GI Bill benefits.
- **Tutorial Assistance and Reimbursement**: Available for more than one "licensing or certification" test reimbursement; however, entitlement is now charged.
- **National Exams**: Reimbursement of fees paid to take national exams used for admission to an institute of higher learning (e.g., SAT, ACT, GMAT, LSAT).
- Non-College Degree (NCD) Programs: Pays actual net cost for in-state tuition and fees at public NCD institutions. At private and foreign institutions, pays the actual net costs for in-state tuition and fees or \$17,500, whichever is less. Also pays up to \$83 per month for books and supplies.
- **On-The-Job and Apprenticeship Training**: Pays a monthly benefit amount prorated based on time in program and up to \$83 per month for books and supplies.
- **Flight Programs**: Per academic year, pays the actual net costs for in-state tuition and fees assessed by the school or \$10,000, whichever is less.
- **Correspondence Training**: Per academic year, pays the actual net costs for in-state tuition and fees assessed by the school or \$8,500, whichever is less.

#### Transfer of Post-9/11 GI Bill Benefits to a Dependent

The Post-9/11 GI Bill also offers some service members the opportunity to transfer their GI Bill to their spouse or children. Any member of the Armed Forces (active duty or Selected Reserve, officer or enlisted) on or after August 1, 2009, who is eligible for the Post 9/11 GI Bill, and:

- Has at least 6 years of service in the Armed Forces on the date of election and agrees to serve 4 additional years in the Armed Forces from the date of election.;
- Has at least 10 years of service in the Armed Forces (active duty and/or selected reserve) on the date of election, is precluded by either standard policy (service or DoD) or statute from committing to 4 additional years, and agrees to serve for the maximum amount of time allowed by such policy or statute; or
- Is or becomes retirement eligible during the period from August 1, 2009, through August 1, 2013. A service member is considered to be retirement eligible if he or she has completed 20 years of active duty or 20 qualifying years of reserve service.

An individual approved to transfer an entitlement to educational assistance under this section may transfer the individual's entitlement to:

- The individual's spouse;
- One or more of the individual's children;
- Any combination of spouse and child.

A family member must be enrolled in the Defense Eligibility Enrollment Reporting System (DEERS) and be eligible for benefits, at the time of transfer to receive transferred educational benefits

Note: After an individual has designated a child as a transferee under this section, the individual retains the right to revoke or modify the transfer at any time.

#### **MONTGOMERY GI BILL**

The Montgomery GI Bill (MGIB) program, commonly known as Chapter 30, provides up to 36 months of education benefits. Generally, benefits are payable for 10 years following a veteran's release from active duty. This benefit may be used for degree and certificate programs, flight training, apprenticeship/on-the-job training and correspondence courses. The monthly benefit paid is based on the type of training taken, length of service, and whether the Department of Defense (DOD) put extra money in the veteran's MGIB Fund (called "kickers").

To be eligible, a veteran must have an honorable discharge, a high school diploma or GED or, in some cases, 12 hours of college credit, and meet the requirements of one of the categories below:

- Category I: Entered active duty for the first time after June 30, 1985; paid \$1,200 into the MGIB program; and continuously served for 3 years, or 2 years if that is what the veteran first enlisted for, or 2 years if the veteran entered the Selected Reserve within a year of leaving active duty and served 4 years ("2 by 4" Program);
- Category II: Entered active duty before January 1, 1977; served at least 1 day between
  October 19, 1984 and June 30, 1985, and stayed on active duty through June 30, 1988,
  (or June 30, 1987 if the veteran entered the Selected Reserve within 1 year of leaving

- active duty and served 4 years); and on December 31, 1989, the veteran had entitlement left from Vietnam-Era GI Bill;
- Category III: Not eligible for MGIB under Category I or II; on active duty on September 30, 1990 and separated involuntarily after February 2, 1991; or involuntarily separated on or after November 30, 1993; or voluntarily separated under either the Voluntary Separation Incentive (VSI) or Special Separation Benefit (SSB) program; before separation, had military pay reduced by \$1,200;
- Category IV: On active duty on October 9, 1996, had money remaining in a VEAP account on that date, and elected MGIB by October 9, 1997; or entered full-time National Guard duty under Title 32, U.S.C., between July 1, 1985 and November 29, 1989, and elected MGIB during the period of October 9, 1996, through July 8, 1997; had military pay reduced \$100 a month for 12 months or made a \$1,200 lump-sum contribution.

#### APPRENTICESHIP AND ON-THE-JOB TRAINING PROGRAMS

GI Bill benefits are available for more than college enrollment. Many veterans are not ready or able to commit to a college program, but few veterans and employers know that benefits are also paid to those who are employed and learning a new skill. Use MGIB benefits to learn new skills while training on-the-job and earning a full-time wage.

OJT training usually requires six months to two years for completion for professions such as a cook, machine tool operator, medical secretary, pharmacist assistant, police officer, or paramedic. Apprenticeship is usually much longer than OJT training, lasting from two to five years in length and includes occupations such as aircraft mechanic, automotive technician, electrician, and welder. Approved programs involve a combination of theoretical instruction and skill training.

#### **MONTGOMERY GI BILL: SELECTED RESERVE**

The Montgomery GI Bill - Selected Reserve (MGIB-SR) Program, Chapter 1606, may be available to a veteran who is a member of the Selected Reserve. The Selected Reserve includes the Army Reserve, Navy Reserve, Air Force Reserve, Marine Corps Reserve and Coast Guard Reserve, and the Army National Guard and the Air National Guard. Veterans may use this education assistance program for up to 36 months on a degree program, certificate or correspondence courses, cooperative training, independent study programs, apprenticeship/on-the-job training, and vocational flight training programs. Remedial, refresher and deficiency training are available under certain circumstances.

Eligibility for this program is determined by the Selected Reserve components; the VA only

makes the payments under this program. Generally, a Reservist has 10 years from the date they first become eligible under this program to use the benefits, provided he/she remains in the Selected Reserve during this time. The 10-year period may be extended if the Reservist is unable to train because of a disability caused by service in the Selected Reserve. If the Reservist is called to active duty, the period of eligibility will be extended by the length of the period of active duty service plus four months.

#### POST-VIETNAM ERA VETERANS' EDUCATION ASSISTANCE PROGRAM (VEAP)

The Post-Vietnam Era Veterans' Education Assistance Program (VEAP), Chapter 32, is available if a veteran elected to make contributions from military pay to participate in this education benefit program. Contributions are matched on a \$2 for \$1 basis by the government. A veteran may use these benefits for degree, certificate, correspondence, apprenticeship/on-the-job training programs, and vocational flight training programs. In certain circumstances, remedial, deficiency, and refresher training may also be available.

Benefit entitlement is 1 to 36 months depending on the number of monthly contributions. A veteran has 10 years from the veteran's release from active duty to use VEAP benefits. If there is unused entitlement after the 10-year period, the veteran's portion remaining in the fund will be automatically refunded.

Contributions may be withdrawn if the veteran does not meet the basic eligibility requirements, or if the veteran formally request a refund of the contributions withheld.

#### SURVIVORS' AND DEPENDENTS' EDUCATIONAL ASSISTANCE PROGRAM (DEA)

The Survivors' and Dependents' Educational Assistance Program, Chapter 35, provides education and training opportunities to dependents of veterans who are permanently and totally disabled with a VA rating of 100% due to a service-related condition, or who died while on Active Duty or as a result of a service related condition. The program offers dependents up to 45 months of education benefits, which may be used for degree and certificate programs, apprenticeship, and on-the-job training. In addition, spouses may take a correspondence course. Remedial, deficiency, and refresher courses may be approved under certain circumstances.

#### **VOCATIONAL REHABILITATION & EMPLOYMENT PROGRAM (VR&E)**

The Vocational Rehabilitation and Employment Program (VR&E) is authorized by Congress

under Title 38, Code of Federal Regulations, Chapter 31 (sometimes referred to as the Chapter 31 program). The mission of VR&E is to help veterans with service-connected disabilities of 20% or higher prepare for, find, and keep suitable jobs. For veterans with service-connected disabilities so severe they cannot immediately consider work, VR&E offers services to improve their ability to live as independently as possible.

The VR&E Program is designed to help a service-connected disabled veteran overcome employment handicaps imposed by such disability, so that the veteran is able to find and keep suitable employment as well as achieve maximum independence in daily living. The primary goal of the program is to train disabled veterans for appropriate employment. Education benefits for school attendance may be authorized if that is determined to be the best way to prepare a particular veteran for entry or re-entry into the labor force. Services generally last up to 48 months, but they can be extended in certain instances.

#### Who is Eligible?

Usually, a veteran must first be awarded a monthly VA disability compensation payment to be eligible for the VR&E Program. In some cases, a veteran may be eligible even if they are not receiving VA compensation. For example, a veteran who is awaiting discharge from the service because of a disability may be eligible. Veterans must also meet the following conditions:

- Served on or after September 16, 1940; and
- Service-connected disabilities are rated at least 20% disabling by VA; and
- Need vocational rehabilitation to overcome barriers to employment; and
- Less than 12 years since the VA notified the veteran of qualified service-connected disabilities.

Recent legislation now allows those who are eligible for both VR&E benefits and Post-9/11 GI Bill benefits to choose the Post-9/11 GI Bill's monthly housing allowance instead of the VR&E subsistence allowance.

#### **VA WORK-STUDY PROGRAM**

The VA Work-Study Program is available to any eligible veteran or their dependents who are receiving VA education benefits and attending school three-quarter time or more. An individual working under this program may work at a school's veterans office, VA Regional Office, VA Medical Facility, CalVet or other approved State employment office. Work-study students are paid at either the State or federal minimum wage, whichever is greater.

#### How does it Work?

To apply for an internship with an approved State Office, the student must attain an enrollment certification VA Form 22-1999-6 from their schools veterans office. The veteran will earn an hourly wage equal to the federal minimum wage or the state minimum wage, whichever is greater, for work completed during or between periods of enrollment. If a veteran is in a work-study job at a college or university, the school may pay the veteran the difference between the amount the VA pays and the amount the school normally pays other work-study students doing the same job as the veteran. A veteran may arrange with the VA to work any

number of hours during enrollment, but the total number of hours worked cannot be more than 25 times the number of weeks in the enrollment period.

#### What are Some Examples of Acceptable Work?

- Processing VA paperwork at schools or VA offices.
- Performing outreach services under the supervision of VA staff.
- Performing services at VA medical facilities or the offices of the National Cemetery Administration.

The work the veteran actually does will depend on the veteran's interests and the type of work available; however, it must be related to the VA. To apply, complete VA Form 22-8691. For more information about education benefits, contact the local County Veterans Service Office.
